- Meet bid form for Phase I Must include
 - Each meet must have its **own Priority** number #1, #2, #3, etc (ex. may not have more than one #1 unless same weekend)
 - **Level** wish to run (it is very helpful if you can signify which days your each level will be i.e. Comp Sat, Opt Sun This will help the assignors and make it more efficient
 - **Number of Session** reminder 8 Judges will only be assigned to 2 session per day meets
 - **Number of Judges needed**
- State Series Bid Form (will be awarded at a alter date)

For those unable make the meeting please **make sure that there is a representative from your club or someone that may know you club calendar to make decisions for you. If there is not a representative that can act in you absence you will have no voice if a scheduling conflict arises and precedence will be given to those that are there**

Illinois Scheduling Meeting

All clubs wishing to host competitions must submit a list of meets at the scheduling meeting.

We will be holding our **Annual Meet Scheduling Meeting** Aug. 3rd at 1:00 at the Aerial Arena Joliet

- ◆ **The meets must be prioritized #1, #2, #3, etc. These must be in the order of importance for your club.**
- ◆ **Each meet must include the Date, Level(s), Number of Sessions, and Number of Judges requested**

Phase 1

Meets you wish to host need to be sent to the State Chairman. He/she (and the NAWGJ Chairman) will develop a Tentative Schedule listing everybody's 1st, 2nd, etc. requests (wishes). This will be produced in calendar form and handed out at the Scheduling Meeting.

Phase 2

At the Scheduling Meeting we will proceed through the meets submitted in **Phase 1** placed on the tentative schedule targeting key weekends and weekends that are over-booked. During a particular weekend those with a **priority #1** will receive the bid. We will proceed with priority #2, etc.

We will only schedule enough meets that will book 80% of the available judges.

Those clubs that do not submit a Meet schedule prior to the meeting **will not be able to participate** at the scheduling Meeting **until Phase 2 of the Scheduling Procedure has been completed.**

Phase 3

We will go through the Calendar again and fill any holes that might have been missed by those that did not participate in Phase 2.

Phase 4

All Meets that were placed on the Official Calendar must then **request judges** (the form is included in IL R&P) Judging requests must include a check.

This form is due August 10th (postmarked) following the Meet Scheduling Meeting.

All meets that have not been requested and paid for by the end of Phase 3 will be dropped from the "Official Calendar."

Why all this?

The last few years the Assignor had great difficulty with assigning meets that came in after the Scheduling Meeting. Therefore, **the meets on the Official Calendar will be assigned judges first.** Then all other meets thereafter may receive judges. We are not excluding that Meet Directors may add meets to the Schedule at a later date, but simply assuring judges to those that followed the Procedure above.



